"Tina Maher from the Career Center at UCD gave me your info. My name is Joel Conn and I am a DVM and business owner from the Class of 2006. My business partner, Deanna Brown, and wife, Sarah Conn, are also alums from 2006.

I am reaching out because I currently own two successful independent veterinary hospitals on the Central Coast in California. Pismo Beach Veterinary Clinic is a general practice and PETS Hospital is an ER/Specialty Hospital. We are looking

for ways to get more involved with the vet school and also to provide some resources to students beyond the typical corporate offerings. We are committed to remaining privately/independently owned and we recognize that this is a dying breed in the veterinary professional world. As such, we have just launched a summer externship program aimed mostly at 1st and 2nd year students. At any rate, I was wondering if SAVMA might be interested in developing a relationship with us having us host a (virtual) lunch-n-learn. Deanna and I can discuss any topic within the realm of small animal practice ownership, remaining independent, business development, building an ER/specialty hospital, maintaining a work-life balance and sanity in a tough career, being a vet in the world of COVID, etc. At least when we were students, this aspect of our education was severely lacking."
